- **Everyone over 16 years old is welcome to battle.**
- **Your data will only remain with us.**  
Third parties or partners will not have access to it if you don't want them to.
- **We treat each other fairly in the arena.**  
Honest, critical voices and clear words are welcome - racism, sexism and glorification of violence will kick our.
- **Collectively, we share the hero stories.**  
We activate our fans and friends, so that many can participate in the energy of the arena an the outstanding battles - and we can all grow together.
- **50/50 rule.**  
According to our core 'Together we Grow' 50% of the proceeds from the NFT sale of your artworks and collectibles belong to you, if you have deposited your wallet with us. If you don't have a wallet yet - we can help in the beginning.
- **You take care that the game is not disturbed.**  
e.g. you are on time and with the right technique at the start.
- **If we disagree, we try to talk to each other and find a fair solution for everyone.**

## **GENERAL TERMS AND CONDITIONS / CONDITIONS OF PARTICIPATION OF THE OFFERS UNITED ARTS ARENA PLATFORM**

The offers and tournaments are carried out by:

All offers are online based battles, trainings and tournaments in different formats.

### **§ 1. General conditions**

§ 1.1 By registering or logging in to this website using the forms and registration procedures provided on this website, or by participating in tournaments organized by United Arts Arena, participants accept the terms and conditions of participation stated here.

§ 1.2 The minimum age for participation in the tournaments is 16 years. All participants who meet the requirements according to the registration form are eligible to participate.

§ 1.3 For participation in the tournaments, each player must provide the following personal data: Team Name, First Name, Last Name, Email Address, Crypto Wallet Address, Phone Number, Age, Discord Name,

Instagram, Website, Telegram and City/Country. These data will be used, processed and stored for the purpose of organizing, processing and running the offer and the tournaments. Furthermore, the participants/inside agree that these data may be passed on and also used for purposes of communication of United Arts Arena and its current partners until revoked. All participants are responsible for the topicality and correctness of their data and must guarantee the accessibility under the data.

§ 1.4 Only one entry per team is allowed per tournament.

Each team may consist of up to 6 people. Each team member must assign themselves to the respective team via registration. If duplicate registrations are made, only one team name or participant will be considered in the tournament and the participant will be contacted.

§ 1.5 The operator and organizer reserves the right to exclude participants for important reasons during the competition. This includes rule violations, cheating, attempts to falsify results, and illegal behavior of any kind. The participant will then also be excluded from future competitions.

§ 1.6 Each team must play its matches with its registered team members in person! Should the suspicion arise that the respective participant is not conducting the games himself/herself, the organizer reserves the right to change the established rules in order to prevent cheating in any form.

## **§ 2 Battles and Tournaments**

§ 2.1 All UAA Battles and Tournaments will be played and partly broadcasted live on the UAA platform/website, using the rules set at the time of registration. All participants registered on this website or registered via the forms and registration procedures created on this website are eligible to play on the platform.

§ 2.2 The participants are divided into groups, leagues or pairings and play the games according to the schedule. The teams and participants will be notified in writing via deposited email.

This will determine the further matches in the course of the tournament. For each tournament there is a predefined time period in which all players must be online, or at the tournament location, to complete the games.

§ 2.3 Painting is done with the app [www.magmastudio.io](http://www.magmastudio.io), a browser-based solution that works best with the google Chrome browser.

In addition to their graphics tablet (iPad, Wacom is recommended), participants should have a webcam as well as a microphone so they can be included in the show.

The exact course of a tournament, as well as all settings and information can be found under the respective info page for the respective tournament.

§ 2.4 When registering for tournaments, participants and teams undertake to ensure participation on the scheduled dates.

If a team or player does not participate in a match for justified reasons, the match will automatically be scored as a defeat for the team or player concerned.

§ 2.5 The organizer reserves the right to make changes to the mode at short notice in order to ensure an organized and fair process.

## **§ 3. Rights and proceeds of artworks and NFTs**

§ 3.1 The copyrights belong to the respective participant who developed/created the artwork. These are deposited in the Smart Contract of the NFT.

§ 3.2 Proceeds from auction/sale of the artwork in the form of NFTs will go 50% to the team or participant responsible for creating it. For artworks created by the team, the crypto wallets of all team members will be deposited in the NFT smart contract.

From the royalties of the resales of the NFT 50% go to the crypto wallets deposited in the smart contract. The amount of the royalties depends on the terms and conditions of the respective NFT auction house used.

§ 3.3 If a participant or team does not have a crypto wallet, the proceeds from the sale can be held in trust by the organizer for a period of 6 months (from Minting). If no crypto wallet is registered for transfer within the 6-month period, these proceeds will be permanently transferred to the organizer. The organizer will use these proceeds in the best possible way for supporting projects for art and culture.

§ 3.4 The organizer may use the content created on the platform (stand and moving images) for its own marketing purposes without restriction. This also applies to the NFTs and recordings of the events. Use by third parties is only possible with the written consent of the author(s) and organizer(s).

#### **§ 4 Further legal provisions**

§ 4.1 All commercial rights in connection with the tournaments belong to the organizer, this includes any marketing and media rights. Unless otherwise agreed, participants are prohibited from carrying out advertising or marketing activities (whether paid or unpaid) in connection with the tournaments and events.

§ 4.2 The organizer shall not be liable under any circumstances for (in particular technical) damage caused by the use of the online platforms and online services. All claims for damages are, as far as legally permissible, limited to cases of intent or gross negligence.

§ 4.3 The organizer reserves the right to make changes to the mode or to postpone game dates at any time and without giving reasons in order to be able to guarantee an organized and fair process. Any costs incurred in this regard will not be reimbursed under any circumstances.

§ 4.4 All participants and visitors to the UAA guarantee that you will comply with all applicable local, regional, national and international laws, rules and regulations relating to the website and the subject matter of the sale of tickets. At the same time, you confirm that you are at least 16 years old and have full legal capacity.

§ 4.5 By participating in the tournaments or competitions of United Arts Arena, participants agree to the privacy policy and information in the imprint on this website.

§ 4.6 There is no legal claim to participation in offers and tournaments as well as winnings/prizes of any kind.

§ 4.7 Place of jurisdiction is the Federal Republic of Germany. German law shall apply.

#### **§ 5 Visitors and tickets to the United Arts Arena**

§ 5.1 Anyone can visit the UAA. Tickets are issued for certain events for a fee and can be purchased in the licensed store or directly on [unitedartsarena.com](http://unitedartsarena.com). Ticket prices are based on the type of event.

§ 5.2 Each valid ticket can participate in the activities provided for this purpose. This also applies to participation in the NFT auctions on [picipo.io](http://picipo.io). For this, the visitor requires a valid crypto wallet on the Polygon network.

Further activities are linked to common online systems such as QR codes and system links as part of the event. The prerequisite for this is an active internet connection. The successful transfer of personal data such as crypto wallet addresses within the framework of the auction, the UAA assumes no liability.

§ 5.3 In the event of an unplanned cancellation of the event, the ticket fee will not be refunded. Season and Cup tickets will be refunded if more than 50% of the planned and announced events cannot take place. Reasons due to force majeure are excluded.

§ 5.4 The ticket is only valid for the deposited event and cannot be transferred.

#### **§ 6 Online Dispute Resolution**

In order to resolve disputes between consumers and entrepreneurs about goods or services purchased online out of court, the European Commission has set up a platform for online resolution of consumer disputes ("OS platform").
